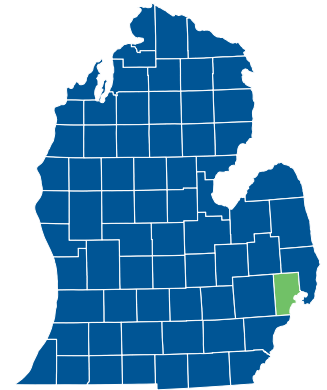


MACOMB COUNTY'S LARGEST ACCOUNTING FIRM
